TAKING YOUR CHILD ON HOLIDAY WITHOUT THE SCHOOL'S AUTHORISATION MAY RESULT IN THE LOCAL AUTHORITY ISSUING A FIXED PENALTY NOTICE TO EACH PARENT/CARER FOR EACH CHILD FOR WHOM THE HOLIDAY REQUEST HAS BEEN REFUSED.

WHAT THE LAW SAYS: Parents should not take pupils on holiday in term time. School will only consider holidays in term time where both:

- The application is made to the Head Teacher in advance of the holiday by a parent the child normally lives with and countersigned by the other parent
- There are exceptional reasons for needing to take the holiday.

Applications should be made as far in advance of the absence as possible.

HOLIDAYS IN TERM-TIME

IMPORTANT: Please read carefully the information below.

WARNING: If you take your child on holiday in term time without the prior approval of the school, you may be liable for a Fixed Penalty Notice per parent per child, in accordance with The Education (Penalty Notices) (England) (Amendment) Regulations 2013.

As a parent/carer, you can demonstrate your commitment to your child's education by taking your holidays during school closure periods

THE FACTS	THE LAW
<p>We recognise that it is often expensive to take a holiday during school breaks and that is why some parents may ask for term-time leave for their child. However, it is important that parents carefully consider the implications of taking their child out of school during term time.</p> <p>Research suggests that children who are taken out of school may never catch up on the work they have missed. This may affect overall progress and assessment or test results.</p> <p>Children who struggle with English or Mathematics may also find it even harder to cope when they return to school, and may also find it difficult to renew friendships with their classmates.</p> <p>WHAT YOU SHOULD CONSIDER</p> <p>There are times during a school year when a child may experience particular problems because of term-time leave such as:-</p> <ul style="list-style-type: none"> • Closeness to assessments, exams or tests. • During the first year at a new school. • At the beginning of a new school term. <p>If the school refuses a request for term-time leave and the child is still taken out of school, this will be recorded as unauthorised absence and you may receive a fine per parent for each child.</p>	<p>The law does not say that parents have an automatic right to take their child out of school for holidays during term-time.</p> <p>However, in exceptional circumstances school may authorise, in advance, requests for periods of leave. The request for leave must come from a parent with whom the child normally resides.</p> <p>If a child then stays away from school without an adequate, truthful explanation, it will be recorded as an unauthorised absence and could be quoted in a prosecution for poor attendance.</p> <p>If the child is away from school for a total of four weeks or more, the school may have to take the child off roll unless there is a good reason for the continued absence, such as a significant illness. In these circumstances it is up to the parent to inform the school, as once removed from roll, there is no guarantee that the child will regain a place at the school.</p> <p>Advice from the Department for Children, Schools and Families in March 2008 states that schools can only approve absence for family holidays if they consider there are special circumstances. Holiday prices, family circumstances and the fact that the parents have booked a holiday before checking with the school, are not special reasons.</p>

<p>Other absence from school will be authorised if it is for the following reasons:</p> <ul style="list-style-type: none"> ▪ Genuine illness ▪ Unavoidable medical / dental appointments (but try to make these after school if at all possible. An appointment card / letter must be provided) ▪ Days of religious observance ▪ Exceptional circumstances, such as bereavement ▪ Seeing a parent who is on leave from the armed forces ▪ External examinations 	<p>Other absence from school will not be authorised:</p> <ul style="list-style-type: none"> ▪ For any type of shopping ▪ Looking after brothers, sisters or unwell parents ▪ Minding the house ▪ Birthdays ▪ Resting after a late night or returning from holiday ▪ Relatives visiting or visiting relatives ▪ Sacraments being received in another country ▪ Lack of adequate child care resulting in child having to go with parent ▪ Passport applications / Embassy visits
